COVID-19 PARENTAL AGREEMENT

In order to minimise the risk of the spread of COVID-19 in schools, the government has produced advice and guidance for schools and families, which has informed our Risk Assessment and Plan for the Phased Re-opening of Bolton by Bowland and Grindleton Church of England Primary Schools.

Please tick each statement to agree that:	TICK
My child will need to arrive and be collected at the times specified in the school's plan.	
I will adhere to the 2m social distancing rules when dropping off and collecting my child.	
I will adhere to the one-way system in operation on the paths at school when dropping off and collecting my child.	
I will not be allowed into the school building unless there is a medical emergency and I will communicate with the school staff via telephone or email.	
(Year five/Six Only) If my child is walking to and from school alone, it will be my responsibility to ensure my child understands and can adhere to social distancing.	
My child will be taught in group of no more than 15 children and that this may not be with my child's current class teacher or in their usual classroom.	
My child will not be able to mix with children or adults from the other group in school.	
Once placed in a particular group, my child will not be able to move into a different group.	
The social distancing rules will apply to all interactions between staff and children at our school.	
I will collect my child if he/she <i>deliberately</i> and <i>consistently</i> fails to adhere to the social distancing rules and the offer of a place for my child will be withdrawn.	
Whilst school staff will endeavour to reduce the risk of the spread of COVID-19 through the measures outlined in the Risk Assessment, they cannot guarantee our school will be risk-free.	
My child will be asked to wash his/her hands using soap and water regularly throughout the day and will use hand sanitiser with an alcohol content of above 60%.	
My child will not bring items from home into school, other than his/her packed lunch and a water bottle.	
To reduce the chances of the transmission of COVID-19 to my home, I will support my child with any personal hygiene measures I see fit when they return from school, e.g. bath, shower, hair washing, hand washing.	
My child wears clean clothing each day to reduce the risk of transmission.	
My child will have their temperature taken upon entry into school. If it is above 38 degrees Celsius, I will be asked to take them home.

Please tick each statement to agree that:	TICK	
I will NOT bring my child to school if they, or ANYONE in the household, displays ANY of the symptoms of COVID-19. If this is the case, the whole household will isolate for 14 days and I will inform school immediately.		
If my child is absent for any reason, I will inform the school in the usual ways before 9.30am on the first day of absence.		
If my child needs any other form of medication, I will need to complete a Medication Form as per the school's usual policy.		
I will inform school staff if I have given my child any medication, e.g. paracetamol, prior to coming to school.		
If my child becomes unwell at school, he/she will be placed in isolation, in accordance with government guidance, and I will be contacted to collect him/her as soon as possible.		
School staff will not be required to prove or justify their decision about my child's illness and that if they believe my child to be unwell, they will act on it.		
If the staff believe my child to have fallen dangerously ill, they will contact the emergency services for help.		
If any of the adults or children in my child's group show symptoms of COVID-19, my child will need to isolate for 14 days.		
If my child requires intimate care, first aid or any intervention at close proximity, the staff will be required to wear PPE to administer it.
